### Summer Camp Location

Camp Seely is the site of the 2018 4-H Summer Camp. Camp Seely is located in Crestline, CA in the San Bernardino Mountains. Camp Seely is owned and operated by the City of Los Angeles Recreation and Parks Department. The University of California 4-H Youth Development Program leases the facility for the week. Our 4-H Camp Program is accredited by the American Camping Association (ACA). We are visited every 3 years with a battery of standards to comply with and Summer Camp 2015 was the latest visit.

### Who Will Be There?

4-H Members ages 8 to 19 years old (as of June 17, 2018) are eligible to attend 4-H Summer Camp. FYI (no outside guest are permitted; unless they have been approved in advance by the Los Angeles County 4-H Office...No exceptions!!!

**\*\*\* No Youth over the age of 15 years old will be allowed at Camp unless they have been to 4-H Summer Camp in previous years.**

### Chaperone's NEEDED!!!

As with any 4-H event, Chaperone's are needed. This need is great for 4-H Summer Camp as it is a week long activity. Each 4-H Club sending 4-Her's to 4-H Summer Camp is required to send one chaperone for each eight campers: two chaperones for nine (9) to sixteen (16) campers; three chaperones not more than 17 campers. We are seeking 4-H leaders who would like to enjoy a week away from home working with dedicated 4-H volunteer staff at Camp Seely

4-H Camp is dependent on volunteers such as chaperones, resource leaders, kitchen staff and adult directors. We encourage all parents and guardians to consider enrolling as 4-H leaders and attending camp with free room and board.

There will be an orientation for chaperones and volunteers before camp, more information will be provided.

Interested Adults/4-H leaders need to contact the 4-H Office by calling (626) 586-1970. Adult Volunteers less than 25 years of age must be reviewed & approved by the Summer Camp Committee by May 6, 2018.

### Camp Fee

The Early-Bird Camp Registration is **\$275.00** and a **\$75.00** deposit needs to be postmarked by June 1, 2018. The Regular Camp Registration is **\$300.00** and a **\$75.00** deposit needs to be postmarked between June 1, 2018 & June 8, 2018. The entire camp cost for ALL Youth needs to be received by June 8, 2018.

**New 4-H Members not currently enrolled in the 4-H Program need to submit an additional check for \$46.00 (Youth) and \$16.00 (Adults) for the 4-H Insurance Requirement.**

### Reservations

The **non-refundable deposit** for the camp reservation is **\$75.00** per camper and the camp cost is **\$275.00** for the Early-Bird Camp Registration by June 1, 2018. The remaining balance is due no later than June 8, 2018.

### Camper pick-up on Saturday

**4-H Summer Camp will end on Saturday, June 23, 2018 at 11:30 a.m. and check out will begin at 11:30 a.m.** Parents/Guardians will have **60-minutes** to pick-up their children. Camper's who are not pick-up by **12:00 p.m.** will be taken down to McDonald's where parents/guardians can get their children. \*There will be a **\$1.00** per minute for late pick-up. **The clock will start at 12noon** and will be collected as **CASH** payment to the Head Adult Director.
